Clean Water Partnership – Prince Georges County entered into a partnership with Corvias, called the Clean Water Partnership (CWP), to meet US Environmental Protection Agency (EPA) Clean Water regulatory requirements. The Clean Water Partnership is currently retrofitting the pond located at Split Rock and Christopher Lane by providing quality water treatment to improve the water quality.

Trash Containers - All trash containers must be stored completely "out of sight" at all times, except on the day of trash pickup. The Potomac Knolls Declaration of Covenants provide that "No garbage or trash containers shall be kept on the front or side yard of any Lot, and garbage and trash containers kept or maintained in the rear yards of any Lot shall be screened (fenced) from public view at all times. Trash and garbage containers shall not be permitted to remain in public view except on the day of trash collection, and after 6:00 pm on the day prior to trash collection."

HOA Fees – Homeowners are asked to ensure that your monthly HOA fee of \$43.60 is received by BB&T Bank by the 1st of the month in order to avoid having to pay late charges, interest, and the cost of collection. To those Homeowners whose accounts are current or paid in advance, we Thank You for being fiscally responsible, and for understanding the impact that the timely payment of monthly HOA fees has on services provided to the Potomac Knolls Community. For Homeowners that are delinquent in the payment of your monthly HOA fees, please be advised that the Potomac Knolls Homeowners Association will be very proactive in ensuring the collection thereof.

Monthly HOA Meetings – The Potomac Knolls Homeowners Association meets every third Thursday of the month at 7:00 pm in the Community Center. These meetings involve discussions on important matters directly affecting every member of the Potomac Knolls Community. Become involved by attending the meetings and let your voice be heard. 

During the Annual Meeting, an election will be held to fill two (2) positions on the Board of Directors. Board member duties include making decisions that are in compliance with the Controlling Documents (Declaration of Covenants, By-Laws, Articles of Incorporation, Architectural Control Guidelines) of the Association, setting policy, establishing procedures, monitoring contracts, and the administration of community affairs. A more detailed description of the duties of Board members, or elected officers, can be found in the By-Laws of the Association. Please note that candidates are running only for the Board, not for a particular office on the Board. It is the responsibility of the Board of Directors to elect Board officers.

It has come to the attention of the Potomac Knolls Board of Directors that notices were mailed to members of the Potomac Knolls Homeowners Association stating that "the neighborhood is using a free private online network called Nextdoor Potomac Knolls".

Please be advised that the Potomac Knolls Homeowners Association is not affiliated with the website and the use of language stating that "our neighborhood is using a private network called Nextdoor Potomac Knolls" is misleading. Also, offering "items for sale" and "share service provider recommendations" represent areas that the Potomac Knolls Homeowners Association cannot commit to because to do so would be in violation of the Association's Controlling Documents and Policy.

In an effort to provide clarity to the Community and eliminate confusion and conflict regarding this matter please know that **Nextdoor Potomac Knolls is a Private Website that is Not affiliated with the Potomac Knolls Homeowners Association.**

The Potomac Knolls Homeowners Association's Controlling Documents provide that "the affairs of the Association shall be managed by the Board of Directors". As such, the Official Website for the Potomac Knolls Homeowners Association is www.potomacknollshoa.com and it was established in the year 2008. The website was established to provide the immediate dissemination of information and thereby increase communication between the Board of Directors and the Community. On average there are over 5,000 visits to our website monthly.

For future reference know that all official communication (Website, Newsletter, Individual Letters or Otherwise) distributed to Homeowners or Members of the Potomac Knolls Homeowners Association will always have the following information on it:

Website – The Potomac Knolls Website provides a platform for the immediate dissemination of information and increased communication between the Board of Directors and the Community. On average there are 5,000 visits to our website monthly. The website address is www.potomacknollshoa.com.

Snow Removal – In an effort to improve Homeowner awareness, it is imperative to know that all calls regarding snow removal from streets in the Potomac Knolls Community should be made to the Prince Georges County Department of Public Works and Transportation (DPW&T) at 3-1-1 from 7:00 a. m. to 7:00 p. m., and 301 350-0500 after 7:00 p. m. Also, go to http://www.princegeorgescountymd.gov/sites/publiceworks to visit the County's website for immediate updates on the status of snow removal or other concerns that you may have regarding snow storm hazards.

Dumpster – Homeowners, Do Not place items in the small dumpster located in the Community Center parking lot because it is strictly for "Private Use Only" by the Daycare and Potomac Knolls Community Center.

Mailboxes – The Potomac Knolls Controlling Documents provide that "mailboxes must be standard black mailboxes on wood posts. Wood posts should remain unfinished to weather naturally, but may be treated with a clear wood preservative." Beware of flyers placed on mailboxes soliciting Homeowners to purchase mailboxes with black or white poles, etc., because they are in violation of the Association's Guidelines.

Power Wash Walkways, Steps, and Driveways:

Many walkways, steps, and driveways in the Potomac Knolls Community are in need of "power washing" to remove excessive dirt to restore them to their natural "concrete" appearance.

Please be advised that "painting" the concrete is prohibited by the Potomac Knolls Controlling Documents.

Bulk Pickup - The Prince Georges County Bulk Pickup Program is ideal for Homeowners that have large bulky items such as old floor model TVs, furniture, etc. that most charitable organizations will not pick up. Simply call Prince Georges County Bulk Pickup at 301 833-4748 and put the items out at the entrance of your driveway the night before the scheduled pickup date. Note that the County has a limit on the number of items that it will pickup per visit. Items may not remain in front of your home beyond pickup date.

Street Light Repairs - Street lights in the Potomac Knolls Community are maintained by the utility company. As a result, burned-out or damaged street lights should be reported to Potomac Electric Power Company (PEPCO) at 877 737-2662. Most repairs are performed within 5 days of notifying the utility company.

Architectural Control – As a reminder, an Exterior Modification Application must be submitted to the Architectural Control Committee (ACC) for approval **before** commencing work on exterior projects (i. e., entrance doors, painting, mailbox changes, decks or sunroom additions, driveway and landscape bricks and pavers, fences, dog kennels, etc.).

Special Note: Homeowners that fail to submit an Exterior Modification Application to the Architectural Control Committee and gain approval prior to starting or commencing work on projects will be fined One Hundred Fifty Dollars (\$150.00). In addition, the Homeowner will be held liable for all charges and legal fees incurred by the Potomac Knolls Homeowners Association in removing or abating any violation that is not in compliance with the Association's Controlling Documents or approved by the Board of Directors/Architectural Control Committee.

Prince Georges County Department of Public Works and Transportation (DPW&T) and Office of Property Standards

The following numbers are provided to Homeowners for you to report problems that you may encounter with the manner that neighboring properties are being maintained. An inspector will investigate within five (5) days of your call, place a notice of violation on the door of the home advising Owners that the violation must be resolved within ten (10) days, and follow-up to re-inspect the property upon conclusion of the time allotted.
